



PONSII ACCREDITATION OF FDNY COURSES

April 22, 2003

1. The Program On Non-Collegiate Sponsored Instruction (PONSII) reviews courses offered by non-collegiate organizations such as FDNY and makes college-level credit recommendations for those courses.
2. The following chart lists all FDNY courses previously evaluated by PONSII, the number of credits recommended by PONSII, and the dates which cover the validation period.
3. It should be noted that all courses are subject to periodic re-evaluation by PONSII and the number of credits assigned could change.
